# **Privacy Policy**

Your privacy is critically important to us.

It is the **SweetThorn Thought Leadership**'s policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to **https://sweet-thorn.com/** (hereinafter, "us", "we", or "https://sweet-thorn.com/"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. #### Website Visitors

## Google AdWords for remarketing
